MEADOW MOUNTAIN'S RAPTORS

Since early spring, several volunteers with Longmont's Raptor Monitoring Program visit numerous raptor nesting sites across the City of Longmont and some outside the city. You will recognize these sites that have nesting platforms on tall wooden utility poles.

According to Scott Severs, who is the Natural Resources Senior Wildlife Technician with the City of Longmont, reports that this is only one nesting site near Meadow Mountain and that is a kestrel box on 75th Street just south of Nelson Road.

In addition to American Kestrels, several other species including Bald Eagles, Barn Owls, Great-Horned Owls, Cooper's Hawks, Ospreys, Red-Tailed Hawks and Swainson's Hawks use the nesting sites.

Your HOA asks our residents to exercise caution, restraint and common sense when approaching a raptor nest. In answer to several questions, Scott Severs goes on to advise that "In general, people should never directly approach a raptor nest, but observe from a safe distance with binoculars and scopes. Use a car as a blind, and if the birds are agitated by your presence (calling and diving at you), you should leave immediately. Keep observations to a minimum, only a few minutes. All dogs on leash, per the citywide policy.

All birds are incubating or attending young now. By the early summer, all owls will have fledged, and hawks, ospreys, and eagles will have nestlings in their nests. By the end of July to mid-August all young will have left the nest.

If anyone is harassing a nest or find an injured bird, they should call Animal Control at (303) 651-8500.
