- New color from updated DRC book: Select a color from the new DRC approved color book.



# **Emergency Warning System**

The City of Longmont made the decision to disable the Outdoor Emergency Warning System. Instead, the city believes that activation of many new mobile weather phone applications and the use of weather radios will provide more efficient community notification for weather-based emergencies. As such, no further testing of the Outdoor Emergency Warning System will occur.

HOW TO GET WEATHER ALERTS: The Longmont Office of Emergency Management encourages residents to use the following National Weather Service (NWS) based notification systems for Boulder County because the emergency sirens are no longer in use:

# **Keeping You and Your Family Safe**

In the tragic aftermath of the explosion of the home in Firestone what can you do to keep you and your family safe? The Department of Public Health at the City of Longmont has a recommendation on CO<sub>2</sub> detectors and the differences between them.

"Odorless gas leaks are difficult to detect. In order to detect an odorless gas leak, an 'Explosive Gas/Carbon Monoxide Detector', which detects 'Propane, Natural Gas, Carbon Monoxide (CO), and Methane' would need to be purchased. Since not all these gases are the same, it is our recommendation to purchase a detector for each floor of your residence.

Since propane is heavier than air, it is recommended to place a detector on the lowest floor, since that is where the propane will settle. Natural gas, carbon monoxide, and methane, are all lighter than air so they will have a tendency to rise, hence the need to place detectors on all floors and especially near natural gas appliances.

These 'Explosive Gas/CO Detectors' may be purchased from a local hardware store or ordered on line."
